



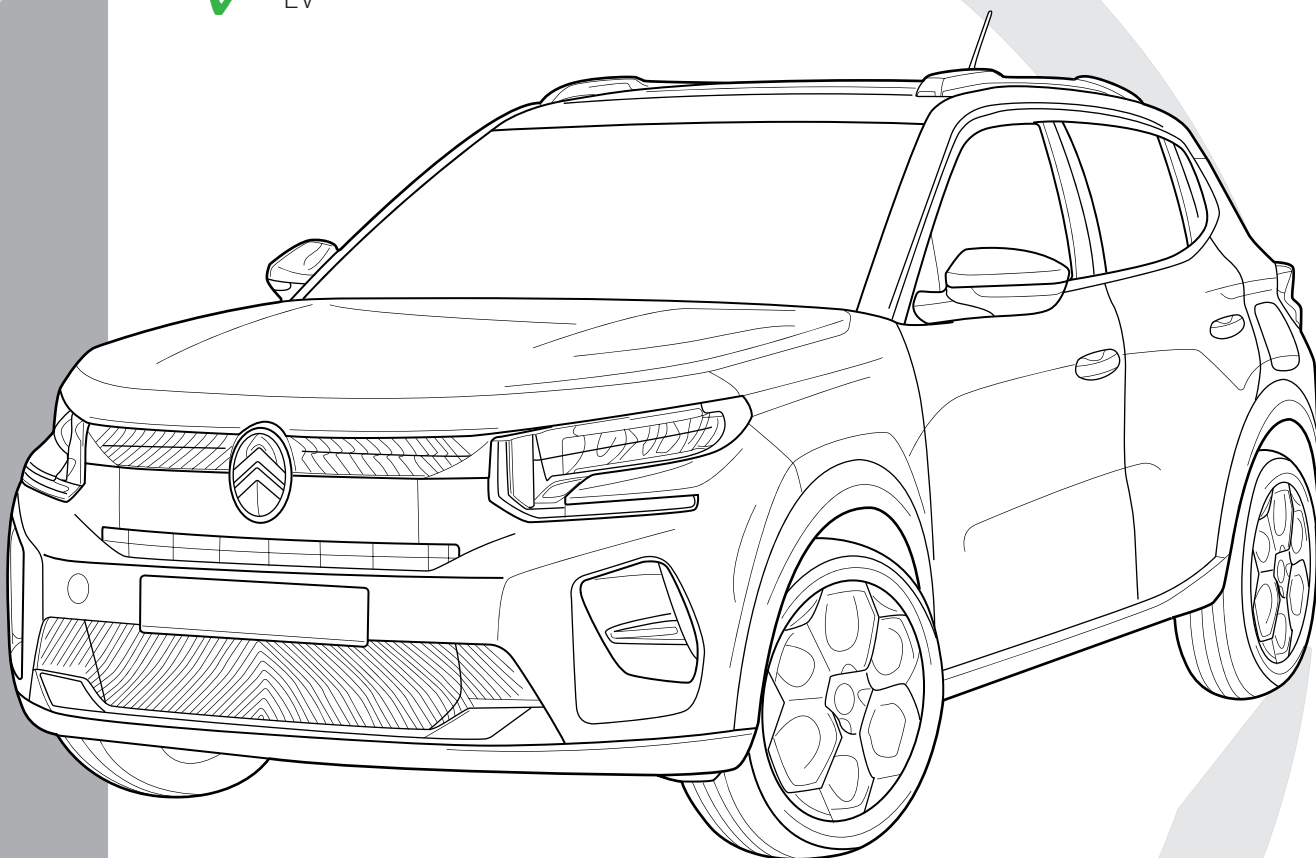

### Fitting

- Present the towbar under the car first to check if all points are right.

### Montage
